Piece of tan color and rectangular shape with fruits inside, characteristic sweet flavor and smell.

INGREDIENTS:

Whole **WHEAT** flour (20%), **EGGS**, fructose, maltitol, sunflower oil, raisins, candied fruit [(pumpkin, fructose, sucrose, preservative E-202, Color E-133 and E-120 and acidifier E-300)], **MILK** powder, corn starch, glucose, sorbitol, raising agent (E-450, E-500II), preservative (E-200, E-281) and aromas. **May contain traces of nuts and sulfites.**
