PRODUCT DESCRIPTION and intended use:

The product is obtained by cooking a mixture of sugar and glucose syrup, and then adding ground almonds and yolk. To finish, the surfaces of the tablet are toasted. Typical sweet flavor, typical smell and texture of yolk nougat.

INGREDIENTS:

ALMOND (35%), sugar, glucose and fructose syrup, **EGG** yolk (10%) and preservatives invertase (E-1103), E-200, E-202 and essence. **May contain traces of gluten, soy, milk, nuts, peanuts, sesame and sulfites.**
