PRODUCT DESCRIPTION and previous use:

Pastry product that is identified as a homemade cake made of golden dough with candied apple mince inside, presented in a rectangular shape, decorated with slices of fresh apple and covered with a light layer of gelatin.

INGREDIENTS:

WHEAT flour, sugar, sunflower and **SOY** vegetable oil in variable proportion, pasteurized **EGG**, fresh apple (10%), candied apple (7%) (apple, glucose syrup, sugar, acidulant (E330), preservative (E202), invert sugar, gelling agents (carrageenan and xanthan gum), raising agents (sodium hydrogen carbonate and disodium diphosphate), **MILK** protein, humectants (sorbitol and glycerin), acidulant (citric acid), preservatives (sorbic acid, potassium sorbate and sorbic propionate) salt, aroma (apple and butter), coloring (carotene). **May contain traces of soy and nuts.**
