#### **INGREDIENT: (Reglament UE 1169/2011):**

**WHEAT** flour, sugar, **EGGS**, sunflower and soybean oil in variable proportions, water, seeds 8% [sugar, cocoa mass, cocoa butter, emulsifier (**SOYA** lecithin)], raising agents (E450i, E500ii), syrup [water, sugar, E330 and E202], humectants (sorbitol, dextrose), glycerin, xanthan gum, preservative (E202), acidifier (E330), aromas (lemon, chocolate) and salt. **May contain traces of milk, sulfites and mustard.**
